Project Management Consultants for Construction Supervision of Three Technology Faculty Buildings (University of Kelaniya, Rajarata University of Sri Lanka and Sabaragamuwa University of Sri Lanka) and Engineering Faculty Building (University of Sri Jayewardenepura)

1. The Democratic Socialist Republic of Sri Lanka received a financing from the Asian Development Bank (ADB) equivalent to US\$ 145 Million towards the cost of the Science and Technology Human Resource Development Project (STHRD Project) under Ministry of Education and intends to apply part of the proceeds of this financing to payments under the Consultancy named in following paragraph No.2.
2. The main objective of the Consultancies is to assist the PMU and PIUs in: (a) reviewing and assessing the existing information; (b) review and monitor project management plan which includes master project time schedule and work breakdown structure; (c) reviewing detailed engineering designs (d) supporting design-and-build contract management; (e) monitoring the civil works based on environmental management plan and ADB's safeguards policy requirements; (f) fulltime supervision and bill certifying at the construction stage and (g) ensuring that the project complies with green building requirements and promote to develop innovative learning environments. 4. The consultancy firms will be selected based on following
 - Consultants are requested to produce one EOI. In the EOI, the consultant may express their interest for one or more consultancy activity. Not more than 8 firms will be short-listed.
 - RFP document will be issued to the most qualified 5-6 consultancy firms for each activity. The Consultant may propose same team leader or different team leaders for different activities. If the same team leader is proposed for different activities, the proposal will be considered up to the selection for one activity and not considered for further activities.
 - Experts other than the team leader can be in several proposals and let them work more than one assignments intermittently if the situation allows.”

5. A consulting firm will be selected in accordance with the QCBS selection procedures set out in the Procurement Regulations for ADB Borrowers by the Asian Development Bank.
